12- ABANA Trailers: organize & inventory trailer contents.

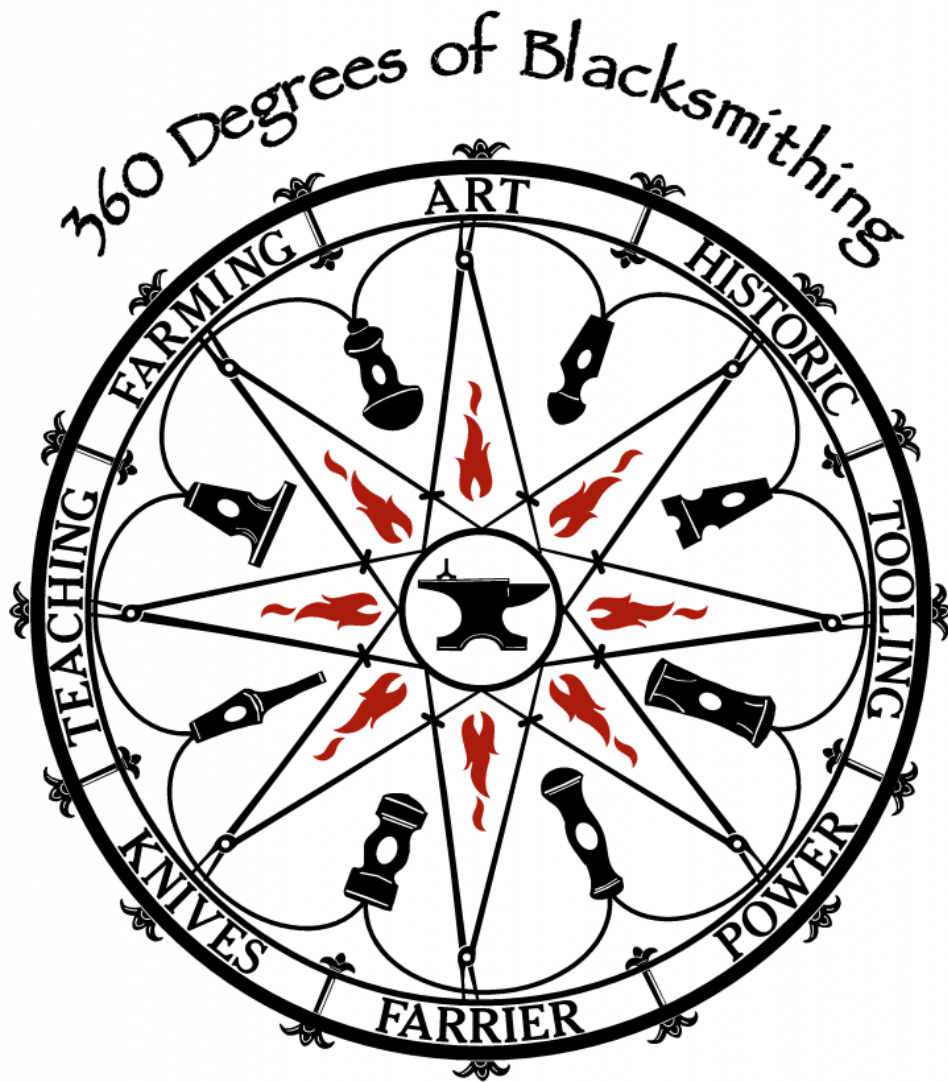
13- Iron in the Hat raffles: ticket sales and managing raffle items.

The 2020 ABANA Conference to be held at the Washington County Fairgrounds near Saratoga Springs, NY, June 3-6. The conference committee consists of Bob Menard, Rand Condell, Bob Valentine, Mark Aspery, Dana Flanders, Dick Sargent, Matt Parkinson, and Leigh Morrell.

2019 Fall Hammer In



Our demonstrator for the weekend is **Douglas E. Wilson** from Deer Isle in Maine. His work displays a quiet elegance of form and thoughtful approach to design. About his work Doug says: “The character of my forged ironwork is the result of careful clean forging and self-imposed restraint. I call it 'distilling chaos'. (Don't put everything you know how to do in every piece of work you make...)”

Doug uses drawing as a tool in his design process. His work also integrates natural materials found in his environment and he is well known for his wrapped beach stones.

The title for Douglas’ weekend demo is:

Contemporary Design Rooted in Traditional Forging Processes

The demo will include a segment on forge-welding which he calls: 'No Myth, No Mystery': Presenting a variety of forge-welding setups & scarfing for a variety of welds.

Doug’s demo: “We will explore design concepts which utilize traditional forging and joinery processes in contemporary ways via drawing. I will forge simple straightforward elements from flat, round, and square bar stock. These elements will then be joined together using traditional processes: rivets, tenons, forge welding, and collaring.

Douglas was our demonstrator many years ago. It was an interesting and memorable demo. Don’t miss this chance to be inspired by Doug’s thoughtful and intuitive approach to forged ironwork. For more on Douglas and his work: www.wilsonforge.com

During the demo he showed us how he would slit and drift holes, isolate the material and forge weld. Watching him work through the process was amazing and all the while entertaining. 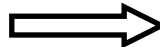

What's new with our e-mail service?

As many of you are aware, we have been having trouble with our e-mail address list. Ever since we started sending electronic invitations for our semi-annual Hammer-Ins, we have had the privilege of using the Ashokan Center's Constant Contact account. This was good, in that it did not cost us anything to create and send e-mails and we could use the same service for event registration. But it had the disadvantage of everyone receiving all the other "non-blacksmithing" emails that the Ashokan Center sent. In 2017, Ashokan was required to send an email to everyone on all their lists that required a reply to stay active on the list. Like so many other people, I did not even open that message, so was put into a suspended "awaiting conformation" category. I had to reach out directly to Constant Contact to get back on the very list that I manage! We lost over a 100 contacts in that incident, about a third of our mailing list, which we are now trying to recover.

The Ashokan Center suffered a similar loss to their mailing list, and thus have changed to a different e-mail and event registration service provider. Our organization no longer has access to use Ashokan's new account, so we will have our own account, shared with the New England Bladesmith Guild. I have looked into a few different service providers, and chose to stay with Constant Contact, that seems to provide the best service for the lowest cost. The additional cost of having our own account has added slightly to the overall registration cost, but that will be offset by a significant savings as we transition to an all electronic version of the Fire and Iron newsletter.

It is important that you get on our electronic mailing list, if you aren't already. You can easily do that by visiting our group website at northeastblacksmiths.org, and clicking on any of the links that say "Join our list". You will then be receiving announcements and invitations to the Hammer-Ins directly from our group. Since your contact information was already in Ashokan's system, you may continue to receive e-mails from the Ashokan Center or Jay and Molly, but you can choose to "unsubscribe" from that list without fear of missing news about upcoming blacksmithing events.

Thanks for your patience and cooperation as we go through yet another organizational transition, and get swept along into the 21st century!

Interview with Bob Cerney



Editor: How long have you been blacksmithing and what brought you to it?

Bob: Since the early 1970's. I was interested in flintlock black powder rifles, locksmithing and farm hardware. I remember finding an old English lock on the family farm. I took it apart and decided to make an exact replica, fully functional.

E: Who and what influenced you over the years?

Bob: Paul Spalding, who was a Master smith for over 30 years at the Cooperstown farmers museum. I took courses with him for several years, then had the opportunity to work directly with him.

E: What did you do for a career?

Bob: Well, I went to school at R.I.T and worked in the radiation labs. That led me to a job working at the University of Rochester as an electrical engineer. During the Korean war, I was put on scientific and professional status and was recruited to upgrade the Army electronics school. I also taught aircraft electronics during the war and they put me in charge of re-writing the curriculum. After the war, I worked in the aviation industry as an electrical engineer, working on aircraft, the turbo train, and Abrams Tanks.

Editor: What type of work do you enjoy the most?

Bob: I enjoy making fully functional miniature engines, gunsmithing and locksmithing.

E: Where were you born and where did you grow up?

Bob: I was born in New York City in 1929 and I grew up on a small farm in Jewett NY. I currently live in Unadilla NY and Florida in the Winter.

E: Can you tell me a little bit about your shop?

Bob: I have a full shop with lots of hand tools, machine tools and computerized controlled machines.

E: How long have you been a member of the North East Blacksmiths?

Bob: Well..I think I missed only one meeting in the last 30 years.

E: Thank you very much for your time!

Bob: Your welcome.

NBA Spring 2019 Meeting Minutes

April 27, 2019

Recorded by Jordan LaMothe

Meeting was called to order at 6:42pm

September minutes were read and accepted

Frank Shaw suggested a need to maintain inventory of supplies in the trailer: Safety glasses, oil, etc.

- it was agreed that requirements for supplies should be sent to Tim Neu, and Frank Shaw will pick them up

Audiovisual equipment:

Microphone — Chris Doherty made a motion to purchase a wireless headset microphone for an amount not exceeding \$200

- Motion approved

Camera — Chris is going to research options. We already have the cables and monitor.

- Frank Shaw made a motion to purchase a camera for up to \$600. The purchase would be made in cooperation with Tim Zowada of the New England Bladesmiths Guild, as the camera would be added to the equipment that is shared between the two groups

- Motion approved

Francis Whitaker tapes:

The intention is to have the tapes available for sale at the Fall Hammer-In and at the ABANA 2020 conference

The production costs according to Chris are \$22 per 17 disc set

- Chris requested reimbursement for \$89 in DVD copies and \$39.39 for software

- Request approved

Volunteer needed to move NBA equipment trailer to Greenwich, NY for ABANA conference

- needs to be there before setup for the conference

- there is a place to park our trailer onsite — the ABANA trailer is already there

- Phil Clark is working on putting tie-downs in the trailer — not yet finished?

- NBA trailer needs to be registered, Tim offered to take care of that

- Tim will also furnish/repair the spare tire for the trailer

- Either Frank Shaw or Dale Martin will bring it to the conference site after the 2020 spring meet

Treasurer's Report:

Tim Neu gave a synopsis of the history of the NBA/Ashokan Center relationship

- Ashokan Center dropped their Constant Contact account, NBA now has our own Constant Contact account and online newsletter

- Tim's current compensation is \$600 in administrative fees for running the event, plus \$100 to store the trailer — approximately 20 hours of work

- Tim has increased time expenditures in order to run the independent newsletter

- Frank Shaw makes a motion to raise Tim Neu's compensation to \$1000 to cover the increased workload

- Motion approved

- Phil Clark and Frank Shaw agreed to repair the masonry on the Shop forge with epoxy and bricks

- Need for NBA branding — Tim Neu will research options for banner over the table and decal on the trailer

- Question — to what extent can we leverage the Whitaker tapes
 - They are a unique product that is unavailable elsewhere
 - They are entirely un-curated — lots of "dead" camera time as it is "real time" recording of demo.

- Need for NBA branding — Tim Neu will research options for banner over the table and decal on the trailer

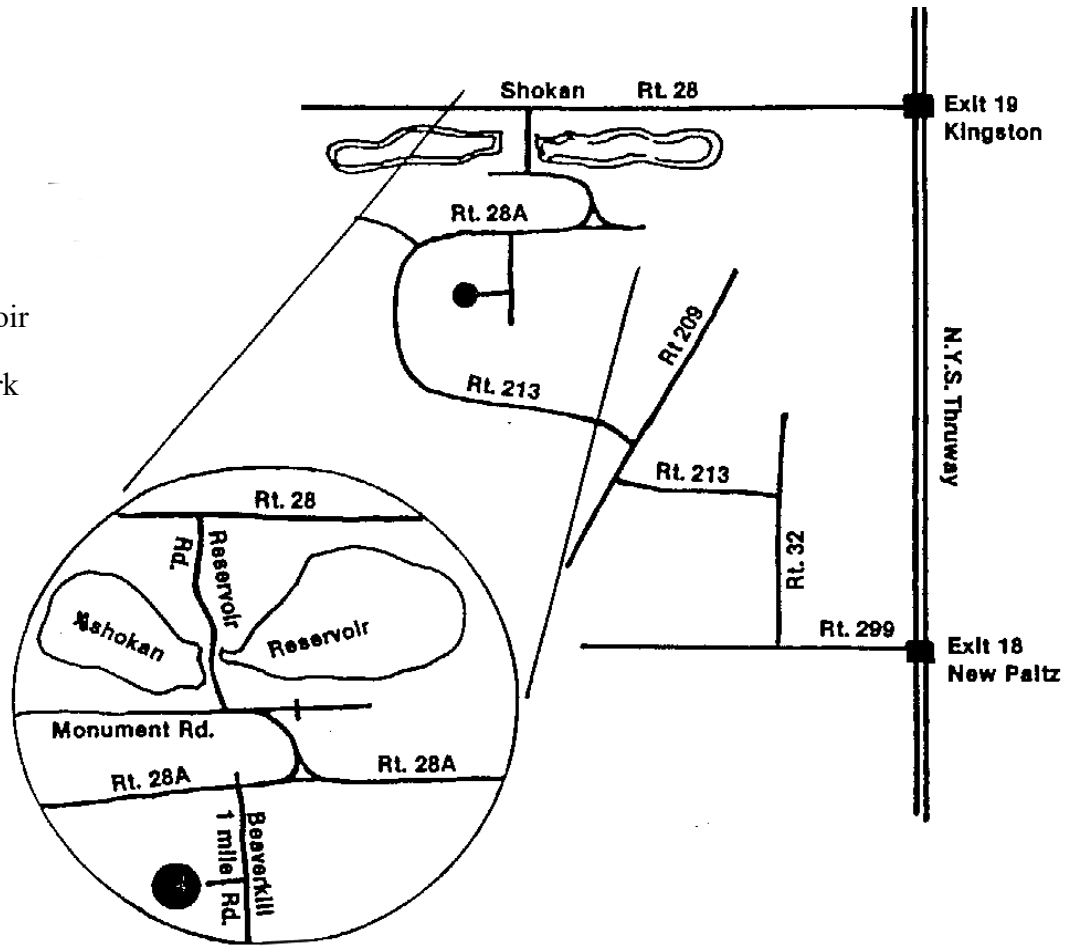
